Session One - Thursday, June 20, 2024, 1:30 p.m.

Opening of Assembly

Assembly 2024 began with Opening Worship with Bishop Michael Pryse presiding, National Bishop Susan Johnson preaching, and many who offered their time and talents as worship leaders.

At the conclusion of the service, Bishop Pryse acknowledged: with hearts of thanksgiving, respect, friendship, and solidarity, we acknowledge that the land on which we gather is the Treaty and Traditional Territory of the Mississaugas of the Credit First Nation, The Haudenosaunee Confederacy, Anishnabeg and The Huron-Wendat and Wyandot Nations, and we acknowledge that we are all Treaty people who share responsibility for action in the spirit of reconciliation.

Bishop Pryse declared Assembly 2024 in session.

Bishop Pryse addressed the Assembly. He acknowledged this as his last report as bishop. He spoke of the ways in which our synod is and needs to continue to be greening. He reminded the assembly of and outlined the election processes for the officers at this convention. He concluded with acknowledgements and gratitude for the synod staff and leadership who have worked with him, and finally for the people of the synod itself.

Report of Nominating Committee

Secretary Wendell Caron Grahlman presented the report of the Nominating Committee for Synod Council.

Nominations for Synod Council, Section 2-1 to 2-12

The following were nominated from the floor: Alicia Becker.

First Ballot – Election of Officers – First Ballot Election of the Bishop. Bishop Pryse called upon National Bishop Susan Johnson for instructions. The ballot was distributed. Rev. Canon Martha Tatarnic led the assembly in prayer. Voting delegates wrote a name on their ballot and subsequently the ballot was declared closed. The ballots were collected by the stewards.

The Secretary outlined the nominations of synodical delegates to the 2025 ELCIC National Convention. Delegates were referred to the nominee names and biographical forms (BR Section 2-19 to 2-43).

Bishop Pryse welcomed the Rev. Dr. Susan C. Johnson, ELCIC National Bishop, to the Assembly (cf BR Section 3-1 ff). Bishop Johnson addressed the Assembly and spoke about the work of the ELCIC in the past few years, some of the work through national conventions. Trina Gallop Blank, Assistant to the Bishop, Communications and Resource Generation, spoke about the new logo and vision statement and how it reflects the hope and priorities of the church. Susan concluded with a round of thanks for Bishop Michael, Eastern Synod members of the National Church Council, and all who have been involved in synodical and congregational leadership.

Report of Canadian Lutheran World Relief

Bishop Pryse welcomed the Rev. Dr. Karin Achtelstetter to the Assembly, the Chief Executive Officer of Canadian Lutheran World Relief (CLWR). She spoke of the work of CLWR as work on behalf of our church and our synod. She expressed appreciation for synod support throughout the pandemic, and the transition of the We Care program. She concluded with an example of inspiration and support from one single congregation for the Canadian Foodgrains Bank.

Report of ELCIC Group Services Inc.

Bishop Pryse welcomed and introduced Lisa Thiessen, Executive Director, ELCIC Groups Services Inc. (GSI) and John Wolff, chairperson of the GSI Board. John spoke of the purpose and goals of GSI, the pension and benefits plan.

Report of Synod Council (continued)

Secretary Rev. Wendell Caron Grahlman introduced the constitutional and bylaw amendments for Assembly action (cf. Section 6-3, and Section 6-4 to 6-6).

ES 24-01 MSC that the Eastern Synod Constitution, Article VI Section 3 be amended (first reading):

Every congregation of this synod shall choose a delegate or delegates to represent it at conventions of this synod and at meetings of the **ministry** area to which the congregation is assigned in accordance with procedures as defined in the bylaws of this synod.

ES 24-02 MSC that the Eastern Synod Constitution, Article XI Section 1 and Section 2 be amended (first reading):

Ministry Areas

Section 1. This synod shall be organized into **ministry** areas whose number and boundaries shall be determined by Synod Council.

Section 2. The role of the **ministry** areas shall be defined in the bylaws of this synod.

ES 24-03 MSC that the Eastern Synod Constitution, Article XIX Section 2 be amended (first reading):

d. Ten convention delegates, representing at least four **ministry** areas.

ES 24-04 MSC that the Synod Bylaw Part II Section 3 and Section 4 be amended:

Section 3. Ministry Areas

a. <u>Ministry</u> areas are groups of congregations that work together in mission led by an Area Leadership Team.

Section 4. Ministry Area Leadership Teams

- a. The bishop, in consultation with synod council, shall appoint <u>a ministry area dean who may, in turn,</u> <u>designate an ministry</u> area leadership team for each area.
- b. The role of the **dean and ministry** area leadership team is to:
 - i. Assist Encourage congregations and ministries within the area to plan, promote and implement the mission of this church;
 - ii. Maintain contact with the synod bishop and staff;
 - iii. Serve as the bishop's representative, as requested, at installations, assisting with the call process, and conducting exit interviews;
 - iv. Maintain contact with Synod Mission staff;
 - v. Work with congregational leaders to create mission strategies;
 - iv. <u>Arrange for continuing education opportunities for rostered and lay leaders to support and encourage area mission strategies;</u>
 - v. Encourage networking and mutual support among rostered and lay leaders;
 - vi. Provide pastoral support to area rostered leaders as required requested.
- c. <u>Ministry</u> area <u>deans</u> Leadership Teams shall report to the bishop annually and at other times as requested by the bishop.
- d. Area Leadership Team members shall be appointed for three year terms and are eligible for reappointment. In the event an Area Leadership Team member is unable or unwilling to serve the full term, the bishop may appoint a replacement to complete the term.
- e. The appointment of an Area Leadership Team member may be rescinded mid-term only upon resolution of synod council.

ES 24-05 MSC that Synod Bylaw Part V Section 12 be amended:

b. The Committee on Nominations shall provide the following information for each nominee: **ministry** area, church/community involvement and vision for the church.

ES 24-06 MSC that Synod Bylaw Part VII Section 1 be amended:

a. Provide pastoral leadership and counsel to ordained and diaconal **rostered** ministers, congregations, synodically recognized ministries and <u>ministry</u> areas of this synod;



ES 24-07 MSC that Synod Bylaw Part VIII Sections 1 and 2 be amended:

Part VIII Standing Program Committees

Section 1.

- a. Standing Program Committees of this synod will have continued existence, formed to do their assigned work on an ongoing basis.
- b. No person shall be a member of more than one standing program committee at the same time.
- c. Standing <u>Program</u> Committees shall be accountable to synod council and shall report to council through the office of the Bishop.
- d. Synod Council shall establish or conclude committees and task forces from time to time as related to the ministry of the synod.
- e. Committee members, who normally shall be a member of an Eastern Synod congregation, shall be appointed by synod council. Synod council may also appoint advisory persons who will be not members of the committee but shall have voice.
- <u>f. Terms of reference for each program committee shall be approved by synod council and kept in</u> a Committee Policy Manual.

Section 2.

- a. Synod Council Committees will be maintained as needed for the ongoing work of the council.
- b. <u>Terms of reference for each committee shall be approved by synod council and kept in the Committee Policy Manual.</u>

ES 24-08 MSC that Synod Bylaw Part IX Section 2 be deleted:

Financial support for Martin Luther University College shall be determined by a process of consultation between the board of governors and synod council.

and re-number Section 3 to Section 2.

ES 24-09 MSC that Synod Bylaw Part X Section 4 and 5 be deleted:

Section 4: There shall be an operating reserve, determined by the synod council, of no more than 15% of the following year's budget.

Section 5: Representatives of synod council shall meet with representatives appointed by National Church Council to agree upon the synod's commitment goal for support of the budget of this church during the next fiscal year. These representatives shall recommend for approval by Synod Council and National Church Council the amount of support to be transmitted through this synod to this church.

and re-number Sections 6 and 7 as Sections 4 and 5.

ES 24-13 MSC that the following be adopted:

That the Eastern Synod recommit to the creation of a climate task force as adopted at Synod Assembly 2021 to assist the ELCIC Carbon Neutrality Task Force, and to assist the Director of Public Policy and Service Ministries in the Climate Justice Portfolio; and

That the Synod provide adequate funding for the development of this task force and for climate justice resources; and

That the Synod create and continually manage lawful protest resources that congregations may use to start or support climate action.

ES 24-14 MSC that the following be adopted:

That the Eastern Synod reacquaint ourselves with the Truth and Reconciliation Commission's 94 Calls to Action, and the United Nations Declaration on the Rights of Indigenous Peoples, and that the Eastern Synod reaffirm our commitment to the work of Truth and Reconciliation and deepening our relationship with our Indigenous neighbours.
