Question: What tips do you have for congregations when establishing and managing the types of restricted funds that were discussed in the [September, 2017 issue of Leaders' Edition?](#)

Response:

As a reminder, a restricted fund is one in which the donor imposed one or more restrictions on the recipient charity at the time of making his/her gift. For example, the donor may have specified that the fund be used for a specific purpose or that the original principal must be retained and only income earned by the fund may be spent. Donor imposed restrictions are referred to as external restrictions. A congregation may also decide to impose internal restrictions on donations that it receives provided that these don't conflict with any external restrictions.


Restricted Fund Tips:

1. As indicated in the September, 2017 article, it is not possible for a congregation (or the original donor/s) to change any restrictions that were imposed by a donor after the gift is accepted. Should a congregation find it necessary to change one or more external restrictions (e.g. if it is impossible or impractical to use the funds as directed) it is necessary to engage the services of a lawyer to obtain a court order (referred to as a *cy pres* application) to have the restrictions changed or removed. This process involves some costs (legal fees and an application fee) and requires substantial effort to research and document the fund in question. Furthermore, the outcome is not guaranteed. As such, this option should be considered only for funds with larger balances where it is clearly evident that the fund cannot be used for its originally stated purpose, but could be used for a feasible purpose which is as close as possible to the original intention of the donor/s.
2. Internal restrictions may be changed or removed by the same body that imposed the original restriction (e.g. congregational council, congregational meeting, etc.), but should be documented properly.
3. Thoroughly document each restricted fund, including: its purpose, the primary donor/s, dates/amounts received, all external restrictions, all internal restrictions and any expenditures from the fund on an ongoing basis from the time it was established. It is also important to retain original documentation related to the establishment of the fund (e.g. copy of wills, gift agreements, church bulletins if there was a "call for donations", etc.).
4. A designated gift (e.g. donation for a new organ) should not be accepted if the purpose has not been approved by the congregation's council, unless the donor agrees (in writing) to modify the restriction to give the congregation discretionary control over use of the funds.
5. When establishing a new Special Purpose Fund or promoting do-
- nations to an existing fund, communicate where extra monies will be applied if the fund is over-subscribed. Periodic reminders should be provided (e.g. on the offering envelope, at each year's annual meeting, etc.)
(Sample Wording: If the Stain Glass Window Fund is over-subscribed, all extra donations will be applied to the Operating Fund.)
6. Establish a gift acceptance policy, follow it and educate your employees and incoming congregational council members about it and why it is important.
7. Do not feel obligated to accept a proposed gift if the congregation does not think that it can reasonably meet the restrictions at present or in the future. Remember that accepting a questionable gift could create a potential breach of trust issue or costs to the congregation for a *cy pres* application.

Benevolence Offerings
