## Continuing Education Plan ( CEP )

### Engaging ELCIC Professional Leaders In Life-long Learning

Did you know that, according to the Letter of Call that outlines the responsibilities of both the called rostered minister and the calling congregation, our rostered ministers are required to participate in the Continuing Education Plan of the Evangelical Lutheran Church in Canada? Why would this be?

Well, let's see what the ELCIC Group Services website says as they are the ones who administer the plan for all rostered ministers in the ELCIC :

"The reality is that the ELCIC expects our professional leaders to possess a thorough grounding in the Christian faith and Holy Scriptures coupled with an understanding of the world and society in which ministry must take place. Servant leaders need to grow continually in under-

standing and competence in order to be faithful in discipleship. The CEP of the ELCIC offers the means by which members may :

1. Further develop present knowledge and skills
2. Acquire new knowledge and skills
3. Experience growth for more effective ministry"

If you are a rostered minister reading this and you are not enrolled in the CEP, I would encourage you to re-think this and honour your call documents. We don't expect the congregational members entrusted to our care to stop growing in faith once they have graduated from Sunday School or been confirmed. Nor should we expect our own growing in faith and learning to end once we have been ordained or consecrated.

If you are a leader in your congregation reading this, I would invite you to inquire if your rostered minister is enrolled in the CEP and if not, why not. That is a question not just for the pastor or diaconal minister but also for the Congregational Council. At the

amount of \$25 monthly contribution by the member and \$50 monthly contribution by the employer, you would be honouring what you agreed to when the call documents were signed. The Continuing Education Plan of the ELCIC is a national program intended to engage and

support life-long learning among our rostered ministers. I'm sure you would agree that is what we need and want. To learn more, I invite you to go to the ELCIC Group Services Inc. website. Click on Plan Documents and scroll down to the CEP documents. It is well laid out. **Engage. Learn. Grow.**

## Has Your Congregation Considered Pre-Authorized Benevolence Remittances?

No doubt you expect and encourage the members of your congregation to make their offerings on a regular basis throughout the year. The synod's cash flow requirements are no different. To meet the synod's budgetary needs, it is important that congregations remit their benevolence and other offerings on a regular (preferably monthly) basis.

Many congregations use the PAR (Pre-Authorized Remittance) program that provides a convenient means for their members to make regular, monthly offerings to the congregation. Did you realize

that this same convenience is available to your congregation to remit its benevolence offerings to the synod?

PAR, a program administered in cooperation with the Department of Stewardship Services of the United Church of Canada, provides an easy, efficient and reliable method for your congregation to remit its offerings to the Eastern Synod by electronic transfer from your congregational bank account. The cost of the program is covered by the synod. Withdrawals are made on congregation's bank account on the 20th of each month, or the following business day if the 20th falls on the weekend. The Eastern Synod's account

is credited on the same day.

Simply divide your annual benevolence commitment/budget (as well as any other regular remittances to the synod by twelve) to determine the amount of each monthly payment. ## ELCIC Women of Faith Fund

The ELCIC Women of Faith Fund provides annual grants that encourage and facilitate the Christ-centred ministry of women within the ELCIC and In Mission for Others. This fund was established in 2011 in recognition of the “significant contribution of the women of the Evangelical Lutheran Women (ELW) of the Evangelical Lutheran Church in Canada (ELCIC)”. The fund came from the monies remaining after the dissolution of the ELW. Individuals or groups may make additional donations to the fund.

Grants from the ELCIC Women of Faith Fund will be available on an annual basis. The deadline for applications is MAY 1. Applicants will submit their proposals to the Women of Faith Fund Advisory Committee which is appointed by National Church Council.

Examples of ELCIC Women of Faith Funds Approved in previous years: Prayer Shawl Ministry, SK - \$1,500; Mustard Seed Family Support, BC - \$9,800; Happy Hearts Quilters, SK - \$2,000; Lutheran Women's Retreat & Spring Connection – SK - \$1,500; Adopt a Room - Hope House Loft Retreat Area, MNO - \$2,000; Peer Partner Programme, ABT - \$3,000; If You Plant A Seed - Putting An Idea Into Action, Eastern - \$5,000; East-West Community Outreach, Eastern - \$7,690; Women in Leadership - Cameroon Companions, MNO - \$5,000. Twenty-eight projects were approved in 2016 (\$42,638 distributed). Further information and the application forms are on the ELCIC website, FaithFund.
